MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for Maurice A. McCreary respectfully requests a **final thirty (30) day extension, until December 12, 2019**, in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be filed with the Court today. The Court has granted counsel two previous extensions.
2. Counsel for Maurice A. McCreary respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Marvin Watson v. The State with this Court on October 3, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Charles Myers v. The State with this Court on September 16, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Travis Lamont Gathers with the Court of Appeals on September 13, 2019.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office consents to this request as shown by signature below.


