As requested, enclosed is the public event sheet for the above case.

As to your motion seeking to have the court reporter transcribe the proceedings in this case, no action will be taken on this motion for two reasons. First, the remittitur was sent in this case on June 26, 2018. The sending of the remittitur ended appellate jurisdiction over this case, and no further motions may be considered by this Court. *Wise v. S.C. Dept. of Corr.*, 372 S.C. 173, 642 S.E.2d 551 (2007). Second, the records of this Court reflect that your counsel ordered the transcript in this case and that this transcript was delivered to your counsel by the court reporter. Therefore, there should be no reason for any further transcription by the court reporter.

Finally, to the extent your letter may be construed as asking me to provide you with a copy of the record on appeal filed in this case, I can provide you with a copy for \$ 174.75 plus a mailing fee of \$24. If you would like copy please send a check

or money order in the above amount payable to the South Carolina Judicial Department. Since I do not find that providing you with a copy of this document without charge would primarily benefit the general public, I will not provide a copy unless the fee is paid.¹ I note that the record on appeal, along with all of the other documents filed by the parties in this case are available for viewing and printing without charge at <https://www.sccourts.org/ACMS/index.cfm>.
