
MOTION FOR COSTS ON APPEAL



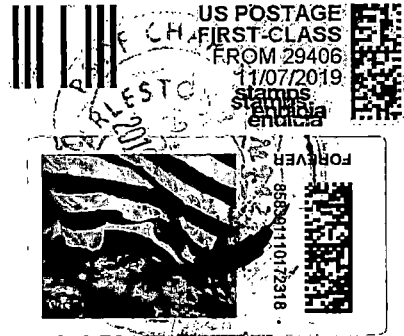
