**MOTION FOR EXTENSION OF TIME
IN WHICH TO FILE
PETITION FOR WRIT OF CERTIORARI**

Pursuant to Rules 240, 242 and 263(b), SCACR, Appellants MJV, Inc./Butler Trucking and Palmetto Timber S.I. Fund c/o Walker, Hunter & Associates, Inc., hereby request an extension of thirty (30) days in which to file their Petition for Writ of Certiorari with this Court. This Court issued Opinion No. 2019-UP-213 on June 12, 2019. Appellants timely moved for rehearing and a substituted Opinion was filed on October 16, 2019. Consequently, Appellants' Petition currently is due on November 15, 2019.


