

Pursuant to South Carolina Appellate Court Rule 203, my office is filing on behalf of the Appellant, CCP Storage, LLC, a Notice of Appeal as to the Ruling of Judge McFaddin, dated November 12, 2019. The jurisdictional authority to file the Appeal with the South Carolina Supreme Court is vested in Rule 203 (d) (1) (A) (ii). The Appellant asserts that the actions of Dorchester County Tax Assessor's Office in the conduct of establishing a new appraised value and a thereby a change of the tax assessment amounted to an usurpation of the authority vested solely with the South Carolina General Assembly under the provisions of Section 6 of Article X of the South Carolina Constitution, as well as Section 12-37-3140 of the South Carolina Code of Laws, 1976 as amended. 
