being duly sworn deposes and says that defendant John Ira Duncan, III did within this county and state on or about 7/19/2015 violate the criminal laws of the

State of South Carolina (or ordinance of County/ Municipality of Beaufort) in the following particulars:

DESCRIPTION OF OFFENSE: Murder / Murder

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

In that on 07/19/2015 at approximately 2020 hours the Defendant, John Ira Duncan (DOB: 08/26/99) did willfully and unlawfully commit the offense of murder in violation of the South Carolina code of laws 16-3-10. The defendant did fatally shoot the victim, Dominique Williams, once in the head with malice and aforethought using a pistol. The defendant fled from the scene on foot and was subsequently picked out of a photo lineup by numerous witnesses as being the shooter. This offense occurred at 1 Coligny Circle (Coligny Beach Access) Town of Hilton Head, Beaufort County, South Carolina 29928. The affiant and others are witness to prove the same.
