
Dear Clerk:

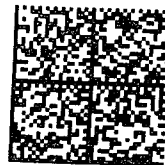
