
This letter responds to your letter dated November 4, 2019, in which you inquire about the above-captioned case in light of the settlement of Appellate Case No. 2018-001808. The second notice of appeal with these parties filed October 7, 2019 (later captioned No. 2019-001690) was a part of the same underlying case and appeal between these parties. The original appeal (No. 2018-001808) had been stayed by Order of this Court dated May 16, 2019, to allow for additional filings in the circuit court. It was my intent in filing the second notice of appeal that it be joined with pending Appellate Case No. 2018-001808. As a result, the settlement resolution subsequently reached by the parties and communicated to the Court in the Agreed Dismissal of Appeal filed October 18, 2019, was intended to dismiss both Appellate Case No. 2018-001808 and Appellate Case No. 2019-001690.

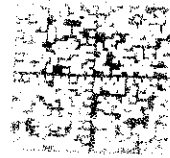
