

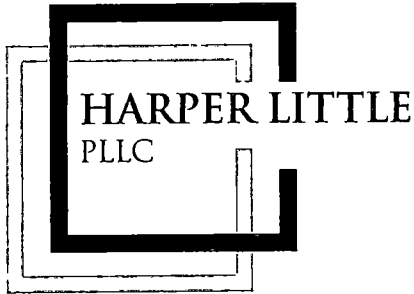

- (3) Pursuant to *Hudson v. Hudson*, 290 S.C. 215, 349 S.E.2d 341 (1986), a refiling fee is not required.

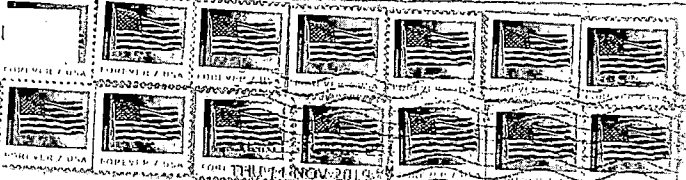
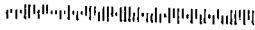
