For me to get copies I have to send them to my family getting them to make copies for me on their time and send them back to me, which takes a lot of time, "which all I have is time in prison" I have to go by their rules so time is very hard in prison.

I sent you the order (Docket NO-19-ALJ-04-

0077- Ap) From Judge Robinson. I then asked for an extension on time to get you the informa pauperis do to S.C.D.C head quarters had not sent me the Form back in time. I received the granted extention on 10-31-19 which gave me until 11-7-19 to get you a copy of the inForm Pauperis Form. I sent that Form to you and General Counsel on 10-31-19. I also sent a (motion to Supplement record), asking the court for permission to send 4 steps of evidence ~~case~~ with my initial brief for proof to prove my argument. I sent that on 11-14-19 and I still have not received any mail from you and today is 11-22-19. The last I heard from your office was when I recieved the granted time extention on 10-31-19. "Is everything O.K, am I doing what needs to be done; correctly???"

I am at (Goodman C.I prison) We do not have a law library Clerk, so when I go I have to do the best that I can IF possible could you grant me Counsel to help me proceed with right Motions, Briefs, Copies, and e.c.t timely.
