


DISMISSAL OF APPEAL





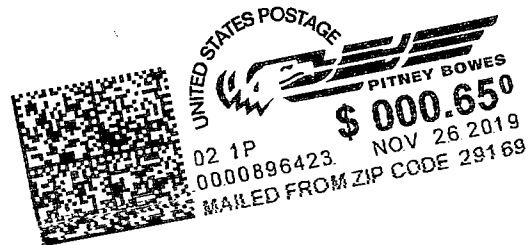
