2. Counsel assures the Court completion of the Brief is a high priority, and she will work diligently to complete it.


3. The undersigned consulted with Appellant's counsel and is authorized to advise the Court counsel consents to the requested relief.

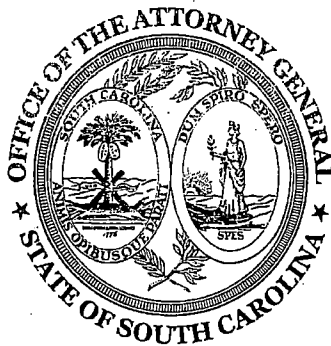
