AMENDED NOTICE OF APPEAL

Alan Nix appeals eleven orders of the Honorable Roger Young and Maite Murphy in the above cited case. Appellants received written notice of the entry of five orders on 7 October 2019, one of which indicated it ended the case. Alan Nix attempted to file, and in the stead, mailed, a Motion to Reconsider on 17 October 2019. The reason for this issue will be explained

under separate cover as required. As of the date of this Notice of Appeal, the Motion of 17 October 2019 does not reflect on the Charleston County Clerk of Court's website, the Appellant has not received a copy of the motion back from the Charleston County Clerk of Court and the Appellant has not received notice of a hearing being scheduled for the motion. A copy of the seventeen page Motion is included as an attachment with this Notice of Appeal.

This Notice of Appeal is being filed on 6 November 2019 to ensure a timely appeal is filed, however, there are several outstanding motions remaining to be heard and/or ruled on.

Kevin Mims represented Churchill Park Homeowners' Association, Inc. and Churchill Park at Parkwest Inc. (which is still not listed with the SC Secretary of State's Office as of the date of this Amended Notice of Appeal) in the Small Claims case this appeal is based on. For some reason Mr. Mims and Mr. Randall Stoney apparently had some issues / risks in representing these apparent clients of theirs in this appeal. Kevin Mims also represents Churchill Park at Park West Association, Inc. (which is also still not listed with the SC Secretary of State's Office as of the date of this Amended Notice of Appeal) in case 2019-00067 which was just appealed last week. Since neither of those entities are listed with the SC Secretary of State's office, it isn't clear to the Appellant if these two entities are the same entity or different entities. Troy Thames and/or Joseph Kaiser represents David Brown and Catherine Brown. Alan Wilson represents Judge Murphy, Judge Young, Ms. Luthringer.
