MOTION TO PLACE CASE ON HOLD

Petitioner, Alan Nix, petitions the Court to grant this motion to place this Writ of Certiorari on hold pending the completion of multiple cases related to criminal conduct by numerous Public Officials and Officers of the Court, including but not limited to, the SC Court of Appeals, current and previous employees of the Office of Disciplinary Counsel, the plaintiff's attorneys, the plaintiff's attorneys' attorneys etc., involved directly or indirectly in this case and its underlying and peripheral cases

ARGUMENT

As previously eluded to, a fairly substantial case could be made that multiple members of the SC Court of Appeals took numerous improper actions during the period May 2018 through August 2019 to obstruct petitioner's ability to have cases 2014-CP-10-05407 and 2017-CP-10-04031 returned to the lower court for the purposes of hearing extremely compelling 60(b) motions, have the record corrected and hear outstanding post trial motions. Since the time this Writ was filed, additional judicial misconduct has occurred related to Judge Maitland Murphy and Judge Deidre Jefferson in cases 2018-CP-10-03315 and 2019-CP-10-00067. Both cases have been appealed within the last six weeks. The willful and knowing misconduct by Murphy and Jefferson in these two cases have provided both additional important acts related to the ongoing pattern of public corruption, as well as a clear consciousness of guilt related to the knowing and willful improper acts in furtherance of the underlying conspiracy.

Additionally, Judge Beatty should review the hand written note on the copy of the motion in Court of Appeals cases 2018-00056 and 2018-00174 dated 17 August 2019 and addressed to him in the care of Court Administration. This is the consequences that note provided a warning of to Judge Beatty if he did not or was not capable of promptly and appropriately reforming the SC Judicial System entrusted to him. It appears the ensuing three months post that cautionary message has generated, to a substantial degree, the exact opposite outcomes than the appropriate corrective measures necessary for the SC Judicial System to even minimally meet its mission criteria. As I'm sure the members of the SC Supreme Court will agree, judicial corruption is perhaps the single greatest risk to a democracy. Unfortunately, it appears South Carolina has not only accepted judicial corruption, but has more disappointingly, embraced it. Therefore, it appears Persons outside of the South Carolina Judicial System and State of South Carolina government institutions must provide the majority of the effort to do what it appears Judge Beatty has not been able to adequately do himself.

Consequently, Petitioner requests the SC Supreme Court to place this Writ in a status of on hold until the numerous acts of misconduct by members of the SC Judicial System are appropriately addressed in judicial forums outside of that of South Carolina. Additionally, the Petitioner seeks an order from the Supreme Court to all other courts within the SC Judicial System to properly preserve all evidence and documents, in any format, related to any case nominally related to this Writ.

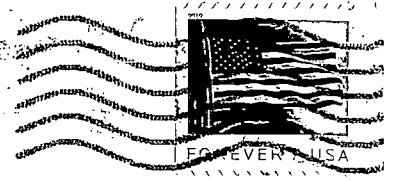
