Pursuant to Rule 212(b) counsel for Appellant Maurice A. Odom respectfully requests to supplement the Record on Appeal, pursuant to Rule 212(b) of the South Carolina Appellate Court Rules. In support of this motion counsel shows the following:


1. On March 6, 2018, this Court granted Petitioner's petition for writ of certiorari as to question number two in State v. Odom, Op. No. 2018-UP-273 (S.C. Ct.App. filed June 27, 2018). The record on appeal was initially filed on November 16, 2016. This Court heard oral argument in the case on December 11, 2019.
2. True Billed Indictments from Edgefield County, dated March 2008, against Maurice Anthony Odom, No. 2008-GS-19-105 for Malicious Injury to Real Property and No.

2008-GS-19-106 for Grand Larceny, were not included in the record on appeal. While the indictments were not marked as exhibits during the pre-trial motion, the indictments were part of the record below and discussed during the oral argument.

3. Counsel now moves to supplement the Record on Appeal pursuant to Rule 212(b) of the South Carolina Appellate Court Rules, to include True Billed Indictments from Edgefield County, dated March 2008, against Maurice Anthony Odom, No. 2008-GS-19-105 for Malicious Injury to Real Property and No. 2008-GS-19-106 for Grand Larceny.
4. Pursuant to Rule 212(b), if the Court grants the Motion, Respondent may also designate supplemental material.
5. Counsel for the Attorney General's office has been informed of this request and provided his written consent below.

WHEREFORE, the undersigned counsel respectfully requests this Court to allow the Record on Appeal to be supplemented with the indictments listed in paragraph 3 in this case based on the above circumstances.


