At a Court of General Sessions, convened on March 3, 2008 the Grand Jurors of Edgefield County present upon their oath:

That MAURICE ANTHONY ODOM did in Edgefield County on or about October 17, 2007, wilfully, feloniously take and carry away the personal goods of the IGA Store, of the value of more than One Thousand Dollars but less than Five Thousand Dollars, described as follows: various articles and goods with intent to deprive the owner permanently of such goods, in violation of Section 16-13-30 (b), with punishment provided for in Section 16-13-30(b)(1) of the South Carolina Code of Laws, as amended.


Against the peace and dignity of the State, and contrary to the statute in such case made and provided.


