

Good Morning, Cyretta,

The subject transcript is needed to perfect an appeal to the South Carolina Court of Appeals. Rule 207(a)(2), South Carolina Appellate Court Rules, requires the court reporter to transcribe and deliver the transcript no later than sixty (60) days after the date of the request, and that records should be transcribed in the order in which they are received. Extensions for Court Reporters are addressed in Rule 207(a)(3).

Rule 208(a)(1), provides that the Initial Brief shall be filed and served within thirty (30) days after we receive the Transcript. Since our time begins to run when we receive the transcript, we ask only that the transcript be delivered within a reasonable period of time.

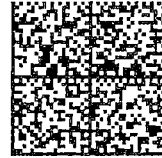
