1) one week before guilty Plea. I had agreed to signed (sentencing sheet) to "one" account of shoplifting enhanced. 0-10 with no recommendation from State. I signed it, my Lawyer, and the Solicitor. I was to leave the Court and return the following day; I was hospitalize the next day. upon Me return the next week, a different Solicitor told my lawyer that deal was off the table. His offer was for 7yrs, to three charges. 1) Grand Theft Auto. 2) Receiving Stolen Goods. 3) shoplifting "enhanced". I refused Plead open 0-10. "I had informed my lawyer I was not guilty of these Charges, he informed me that my prior convictions, would convict me. (Judge gave me 3 1/2 year on all 3 charge" Concurrent of 3

I remind the Court, I didn't do anything, within the 7 day, no additional charge or any wrong doings.

(2) - My Co-defendant Melanie Kirchner, had already Plead to the Receiving and Grand Jury charges, and was represented (Also) by the same Public Defenders Office and received (5) days time served. Myself knowing she had given statements to the same Office, I could not present a defense, being that the Public defenders office and the same Solicitor prosecuted her also (Debois) (?) what happen to a (Conflict of interest).

(3) The Solicitor (Debois) Brought up to Judge, Charges of Crimes I hadn't Never been convicted of. (Malicious Prosecution).

(4) All other Charges Pending were to be dismissed and/or Not-Prosecuted. on 8/23/19 I had to Plea Guilty to another shop lifting 2nd (Two days after) general Sessions 8/31/19 AT J. Reuben Long Det. warrant # 2019A2610200165 which again Violates our Guilty Plea Agreement.

#(5) - Several years back my son - Ricky Tony Galloway Jr got into a Physical altercation with "Solicitor" for 3 yrs the Charges were dropped, then Brought up again 3 differant times. Then finally dismissed. At which I Galloway Sr. Believe was the reason for the change of Solicitor (who also Prosecuted Co-defendant) Took earlier Plea agreement, off table, and recommend 7 yrs instead of the 2 yrs.

#(6) The Same Representative for the State in this Present Appeal Ms Shariff Crawford is the Appointed Public Defender that represented my Co-defendant Melaine Kirchner

#(7) My Lawyer (James Stanko) Lied and mislead the appealant Court, By stating in writing #4. I informed defendant that there is no issues to appeal & He has never spoke, seen me since Court's
