thank you God Bless Merry X & Happy New Year

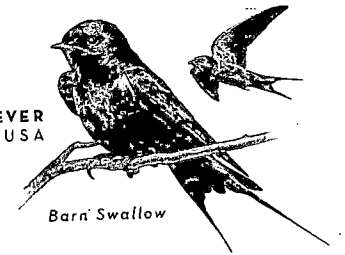
