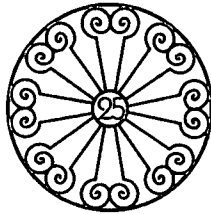


Of course, if you have any questions or concerns or if a formal motion is required for the Court to consider the requested extension, please just let me know.

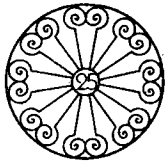
