
**MOTION TO EXTEND TIME TO FILE  
INITIAL BRIEF AND DESIGNATION OF MATTER**

The Appellant hereby moves to extend the time to file his Initial Brief and Designation of Matter. This motion is based upon the following:

1. That pursuant to an Order dated December 10, 2019, our Initial Brief and Designation of Matter is due December 20, 2019.


