To Whom it may concern:

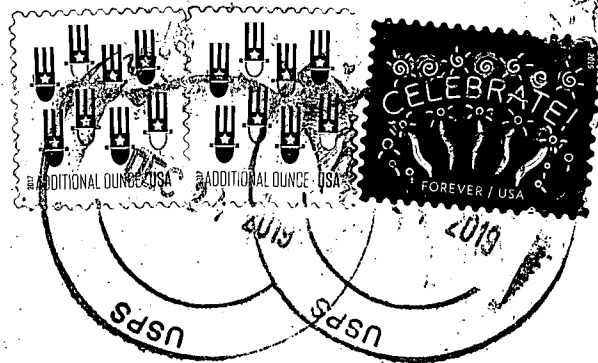

Hemmings is disabled and has been since June 6, 2007 at age 46 and had second heart attack May, 2013. He applied for Social Security several times but was told he doesn't have enough points in the system. Right now we are in a financial bind.
