

I am appealing to this Court from a ruling in the Court of Common Pleas Dorchester County decided by Judge Goodstein on 30 October 2019. I received the Courts Decision on 7 November 2019.

I appeal to this Court to resolve a issue which arises out of 14-8-250 South Carolina code of law for rules of appeal.

"In every decision rendered by the Court, every point distinctly stated in the case which is necessary to the decision of the appeal and fairly arising upon the record of the Court must be stated in WRITING and must, with the reasons for the Courts decision, be preserved in the record of the case; provided, that the Court need not address a point which is manifestly without merit."

I raised two points with merit in South Carolina law. Therefore, the Court was duty-bound to respond in WRITING the reasons for the Court Decision.

The Court responded with one word "affirmed" the lower Courts decision WITHOUT explanation, this clearly violates 14-8-250 South Carolina code of laws.
