NOTICE OF APPEAL

Appellants Action Resources, Inc. and Travis Powe appeal the entirety of the Circuit Court Order of the Honorable Edgar W. Dickson dated and filed November 1, 2019, granting Plaintiff's and the Shores Defendants' Motions to Dismiss the Shores Defendants from the Plaintiff's Complaint, allowing that Plaintiff may amend the Summons and Complaint to remove the Shores Defendants and all allegations related to the Shores Defendants, and that the cross-claim filed by Defendant Action Resources, Inc. against the Shores Defendants be severed from Plaintiff's claims against Defendants Travis Powe and Action Resources, Inc. Appellants received written notice of entry of this Order on November 1, 2019. Appellants filed a Motion for Reconsideration on

November 5, 2019. An Order denying Appellants motion for reconsideration was issued on December 6, 2019.




