MOTION FOR EXTENSION OF TIME,
OR FOR THE RIGHT TO FILE OUTSIDE TIME

Pursuant to Rules 263(b) and 240, S.C.A.C.R., the Appellants, by their counsel undersigned, move this Court for an order granting an extension of time in which to serve their Initial Brief and Designation of Matter to Be Included in the Record on Appeal, or to be allowed to serve the same outside time, on the grounds stated below:

1. According to this Court's Rules of Procedure, the Appellants' Initial Brief and Designation of Matter to Be Included in the Record on Appeal was due as of thirty days after counsel's receipt of the requested, second transcript; the transcript of the requested first hearing had been received previously to the events below.
2. That second transcript was in fact received by e-mail attachment on November 17, 2019 By inadvertence, the deadline created by that receipt was not calendared in Appellants' counsel's

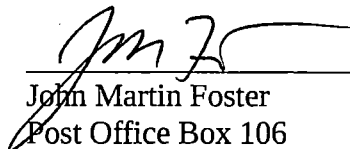
records. Counsel became aware of this error after his receipt of this Court's inquiry as to status dated January 3, 2020 and received January 6, 2020.

3. Counsel has been prevented from completing the initial Brief and Designation of matter owing to trials, the absence of his employee due to the season and closure during the holidays, and the press of business in his office.
4. Counsel for the Appellants believes the same can be supplied if a thirty (30) day extension period is allowed. This is his first request for an extension of time.

The basis of this Motion is the within-cited Rules, the records of this appeal, which items are hereby incorporated in this Motion.

WHEREFORE, the Appellants herein move this Court for an extension of time, or for the right to file outside time, for a period of thirty (30) days in which to serve their Initial Brief and Designation of Matter to Be Included in the Record on Appeal .

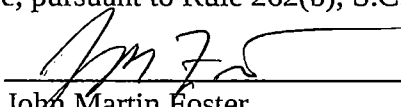

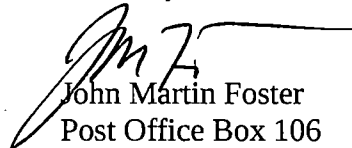

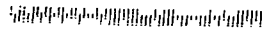
