SECOND REQUEST FOR AN EXTENSION OF TIME  
TO FILE APPELLANT'S INITIAL BRIEF & DESIGNATION OF  
MATTERS TO BE INCLUDED IN THE  
RECORD ON APPEAL

COMES NOW, the Appellants, Karrie and Howard Gurwood, respectfully moving before this honorable Court for an extension to serve and file the parties' Briefs and Designations of Matter to be Included in the Record on Appeal as the Appellants. Appellants' previously requested this Court for a sixty (60) day extension based upon the following: (1) Appellants' Counsel had long standing international travel plans with family from November 19, 2019 to December 2, 2019, further, (2) Appellants' counsel on jury trial rosters for the weeks of December 2, December 9, and December 16th in various counties; and also the Hanukah, Christmas and New Years holidays occurring thereafter. Since the submission of Appellant's last request, Appellant Appellants' Counsel was also on the jury roster in Charleston County for January 6, 2019 and January 13, 2019 in a separate matter

Accordingly, Appellant respectfully requests under these exigent circumstances for a final extension of thirty days to file the Initial Brief and Designation of Matters.

Appellants have conferred with Counsel for the Respondents, who have consented to such an extension. Appellants have not styled this Request as a "Joint" or "Consent" request as the document does not contain the signature of Counsel for the Respondent, however, Appellants have communicated via email regarding the agreement and have memorialized same in email correspondence with Counsel for the Respondent. (A copy of which is attached hereto as "**Exhibit A**" and incorporated by reference herein.)

**WHEREFORE**, based upon the foregoing the Appellants would at this time respectfully and humbly pray this honorable Court for an Order extending the time in which to serve and file the parties' briefs and Designations of Matter to be Included in the Record on Appeal along with any other such further relief as this Court may deem just and proper.





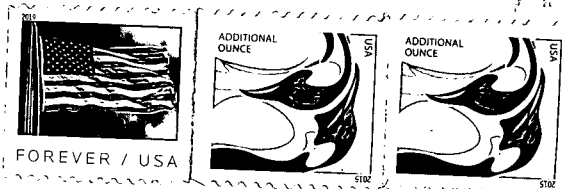
