as grounds therefore, states as follows:


1 Appellant and Respondent have reached a resolution of the matter that is the



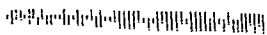
