
As indicated in my letter of August 29, the parties in August wrote to Chief Justice Beatty, asking him to assign now-retired Judge Early to hear the pending Rule 59(e) motion. As indicated in my letter of October 11, after not receiving a response for some time, I contacted Brenda Shealy at the Clerk's Office. Apparently as a result of that call, one of Plaintiff's counsel was contacted on October 4, by Court Administration, which advised that Judge Early could not serve because he had signed an election not to serve. Court Administration further advised that they were going to assign someone else to the case, but as of this date we have not heard anything further.

I will provide another status report on or about February 7, 2020, unless something happens in the meantime.
