
On December 3, 2019, Lagroon requested the Official Transcript from Angela P. Berry. (Exhibit 1).



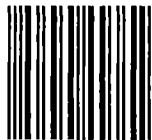

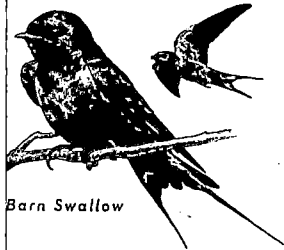
