MOTION FOR AN EXTENSION OF TIME  
IN WHICH TO FILE THE PETITION FOR WRIT OF  
CERTIORARI AND APPENDIX

Counsel for Travis Hair respectfully requests a **final thirty (30) day extension, until February 20, 2020**, in which to file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today. The Court has granted counsel two previous extensions.

2. Counsel for Travis Hair respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Tykeem May v. The State with this Court on December 2, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Ronnie Martin v. The State with this Court on November 25, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Willie Byrd with the Court of Appeals on November 20, 2019.


4. Counsel makes this request in good faith and not for purpose of delay.


5. Counsel for the Attorney General's office has been informed of this request as shown by signature below.


