


Dear Ms. Kitchings:

Thank you for your patience and assistance.

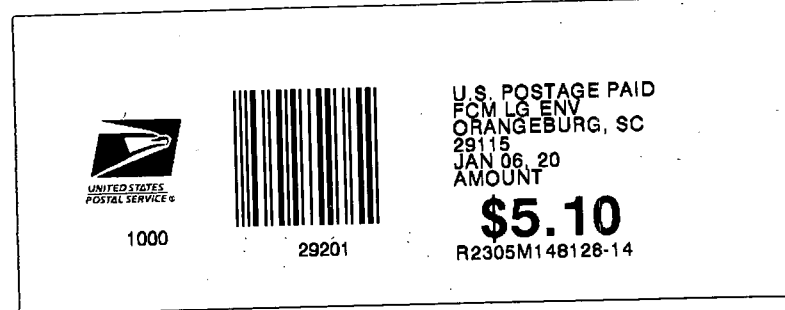
