

NOTICE OF APPEAL

Shi Heme Raquan Price appeals the order denying him Immunity Under the Protection of Persons and Property Act by the Honorable Donald B. Hocker, dated June 21, 2019, and filed on or about June 21, 2019, with the Abbeville County Clerk's Office. Appellant timely filed a Motion to Reconsider. On January 6, 2020, Appellant filed an additional motion perfecting the issues originally raised in his Motion to Reconsider. The Honorable Donald B. Hocker verbally denied Appellant's Motion to Reconsider on January 7, 2020. The case then proceeded to trial and ended January 8, 2020, with a negotiated plea of guilty to voluntary manslaughter. Appellant respectfully, by and through his attorney of record, Stephen Geoly, gives Notice of his Appeal of Judge Hocker's denial of immunity. Appellant is not appealing the guilty plea.





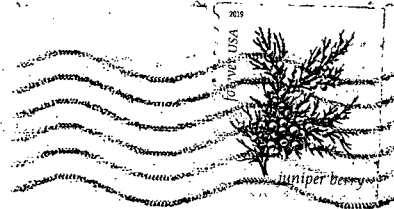
