MOTION FOR COSTS

Pursuant to Rule 222, SCACR, Petitioners Devery A. Hale and Tina T. Hale request that the costs of this appeal be taxed against Respondents Winrose Homeowners' Association, Inc. and Regime Solutions, LLC. Rule 242(j)(1) provides that, unless the Court orders or the parties agree otherwise, "[w]hen the decision of the Supreme Court has the effect of reversing the judgment of the lower court or tribunal which was on appeal, costs shall be assessed against the respondent before the Court of Appeals." Rule 242(j)(1), SCACR. On December 18, 2019, this Court reversed the decision of the lower court and Court of Appeals, ruling in Petitioners' favor. Respondents did not file a petition for rehearing. On January 15, 2020, this Court issued the Remittitur. Under Rule 242, the Court shall award costs to Petitioners. In accordance with Rule 242(j)(4), an itemized statement of costs is attached to this motion.


