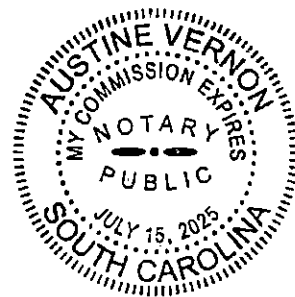
The Plaintiff argues that the motion for reconsideration was file on July 26, 2019: The Clerk of Court did send a Notice of Court Date by way
