APPELLANT'S REQUEST TO WITHDRAW APPELLANT'S LETTER FOR DISMISSAL



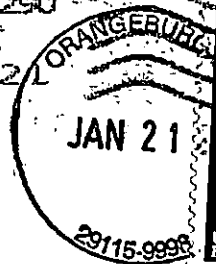
