**ORDER GRANTING PLAINTIFF THIRTY (30)
DAYS TO SECURE AN ATTORNEY**

ORDER GRANTING PLAINTIFF THIRTY (30) DAYS TO SECURE AN ATTORNEY

This matter came before the undersigned on June 25, 2019 for a hearing on Defendant Bank of America Corporation’s Motion to Dismiss. At the hearing, the Court elected not to hear argument on the motion, and instructed Plaintiff to notify the Court within thirty (30) calendar days that he has either (1) retained a licensed South Carolina attorney to represent him in this matter; or (2) is electing to proceed *pro se*.

Accordingly, **IT IS HEREBY ORDERED** that, no later than July 25, 2019, Plaintiff must file with the Clerk of Court a document explaining whether (1) he has retained a licensed South Carolina attorney; or (2) he is electing to proceed *pro se*. In the event Plaintiff retains an attorney, his July 25, 2019 submission shall include the attorneys’ name, address, telephone number, and South Carolina Bar Number.

In the event Plaintiff intends to move to compel Defendant Bank of America Corporation to indemnify him for any attorneys’ fees or other costs that he may incur in the course of this

proceeding, then Plaintiff must file any such motion with the Clerk of Court no later than July 25, 2019. The Court will set any such motion for hearing in due course.
