
I am in receipt of your January 13, 2020 letter regarding the caption of the above referenced matter. This lawsuit was initially filed in Horry County, South Carolina in 2017. At the time it was filed, Susan B. Byerly and John Byerly were named as Plaintiffs and there were three (3) named Defendants: Thomas Wesley, Brown Rooftops, LLC and Bay Service Contracting, LLC. Mrs. Byerly passed away unexpectedly on May 26, 2018 and Mr. Byerly was named as Personal Representative of her Estate in March 2019. I have attached a copy of the Certificate of Appointment for your review.

Plaintiffs reached a settlement with Defendant Brown Rooftops in May 2019 and a Stipulation was filed with the Court dismissing it from the case. The Defendant Bay Service Contracting, LLC never made an appearance in this action and was voluntarily dismissed from the case at the call of the trial of the case. Thus, Thomas Wesley was and is the only Defendant against whom the case proceeded.
