MOTION TO STRIKE

NOTICE THAT CHIEF JUDGE NEWMAN GRANTED HIM PERMISSION TO APPEAL ALL CIRCUIT COURT ISSUES IN PERSON IN THE CLERKS OFFICE OF THE CIRCUIT COURT AND THE ORDERS OF JUDGE JACQUELINE BELTON ARE NOT RELEVANT AND SHOULD BE STRICKEN

Petitioner notes that Judge Newman granted him permission to appeal, and letters from James R.
