**NOTICE OF RECEIPT OF RECORD AND INTENT TO FILE COPIES OF TEXAS APPELLATE
BRIEFS IN THIS COURT AS APPELLANTS ANSWER**

Court of Appeals

- APPELLANT NOTIFIES THE COURT THAT HE HAS RECEIVED THE PREVIOUS RECORD IN THIS CASE; AND INTENDS TO SERVE THE COURT A COPY OF TWO BRIEFS HE FILED IN THE TEXAS APPELLATE COURTS WHICH ARE VOLUMINOUS INCLUDING EXHIBITS.
- FURTHERMORE, APPELLANT HAS A COPY OF A VERBAL DEPOSITION TAKEN AFTER THIS PERIOD OF TIME WHICH DISCUSSES ISSUES WHICH HAVE ARISEN SINCE THE PREVIOUS FINAL ORDER OF THE TEXAS COURTS OF APPEALS IN 2011. IN OTHER WORDS IT DISCUSSED THE PERIOD FROM 2011-2020 (NINE YEARS POST JUDGMENT) WHICH IS WHAT THIS CASE IS REGARDING.
- APPELLANT ALSO NOTES THAT HE REQUESTED THE US SUPREME COURT REVIEW THE ORIGINAL CASE IN 2011, BUT THAT THE SUPREME COURT DECLINED BECAUSE THEY DID NOT DEEM A CLERK ORDER OF A DENIAL OF A PETITITON FOR REVIEW TO BE A FINAL ORDER OF THE HIGHEST COURT IN THE STATE, AND THEY HAD EFFECTIVELY ORDERED THE LOWER COURT TO ENTER A FINAL JUDGEMENT OF SOME SORT BY CLERK LETTER WHICH THE TEXAS SUPREME COURT IGNORED.
- BY DENYING A FINAL ORDER IN A US COURT OF APPEALS, OR THE US SUPREME COURT WHICH IS A PUBLISHED OPINION, THE US SUPREME COURT BELIEVES ITS INVALID, AND NOT SUFFICIENT FOR A PETITION FOR WRIT OF CERTORARI.
- PETITIONER IS IDENTIFYING THIS ISSUE FOR THIS COURT SO THAT IT CAN IN FACT TELL FOR ITSELF, THAT THE US SUPREME COURT RULES WHICH ARE PUBLISHED ARE NOT COMPLETE, THEY DO NOT INFORM THE PUBLIC, THAT THEY ONLY PUBLISH STATISTICS FOR CASES THEY HAVE RECEIVED WHICH THEY BELIEVE A VALID JUDGEMENT FROM A STATE SUPREME COURT OR US COURT OF APPEALS HAS CONCLUDED(AND THEY SELDOM DO PUBLISH THEM).
- IN OTHER WORDS THE DREAM OF LITIGATORS OF HAVING THE US SUPREME COURT REVIEW A JUDGEMENT IS MUCH MORE DIFFICULT THAN EXPECTED OR TOLD TO EVEN LAW STUDENTS IN PRACTICE EVEN THOUGH THE RULES SAY DIFFERENTLY. THE HIGH COURT IMPLIES EVERY WRIT OF CERTORARI IT RECEIVES GETS AN ORDER OF ACCEPTANCE OR DENIAL.
- FURTHERMORE IF YOU ARE NOT INDIGENT, THE COST TO FILE A VALID BRIEF AND COPIES IN THE SUPREME COURT OF THE UNITED STATES INCLUDING TRAVEL IS MORE THAN \$50,000 (AND I HAVE DONE IT FOUR TIMES BEFORE) BUT THREE TIMES I DID NOT HAVE SUFFICIENT RESOURCES BUT LIVED RELATIVELY CLOSE BY THE COURT.
