MOTION TO STRIKE

NOTICE THAT CHIEF JUDGE NEWMAN GRANTED HIM PERMISSION TO APPEAL ALL CIRCUIT COURT ISSUES IN PERSON IN THE CLERKS OFFICE OF THE CIRCUIT COURT AND THE ORDERS OF JUDGE JACQUELINE BELTON ARE NOT RELEVANT AND SHOULD BE STRICKEN

Petitioner notes that Judge Newman granted him permission to appeal, and letters from James R. Stritzinger Jr, a man with a treated narcissistic personality disorder by the State of South Carolina, and previous filings which were done in the probate court without evidence presented are not relevant to his appeal either in this court or in the Supreme court, and have not yet been tried in the Circuit court, and orders reviewing a case which has not been tried is premature.
