**MOTION TO AMEND APPENDIX**

Undersigned counsel for the State respectfully moves for permission to file an Amended Appendix in this case. In support of this motion, counsel would respectfully show the Court:

1. The Appendix to the State's Petition for Writ of Certiorari was filed with the Court on February 9, 2018. The Court subsequently granted the State's Petition for a Writ of Certiorari on August 5, 2019.
2. Both parties have since discovered an error on page 342 of the Appendix. This page of the Appendix should reflect page 342 of the trial transcript. Instead, page 345 of the trial transcript appears in its place. Page 345 of the trial transcript also appears in its correct location (page 345 of the Appendix). Thus, page 345 of the trial transcript appears twice in the Appendix, and page 342 was not included.

3. Counsel for the State has communicated with Counsel for Respondent regarding the best course of action to correct the error. Both parties are in agreement that the State should file an amended appendix with the Court.

4. The proposed Amended Appendix is attached and submitted concurrently with this motion.

WHEREFORE, undersigned counsel would respectfully request an order from this Court granting the State permission to file an Amended Appendix to correct the error articulated above.
