All of these filings indicate that they were served upon me (mailed by certified mail) on January 10, 2020. An example of Appellant's proof of service is enclosed.



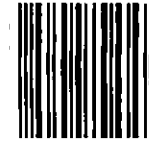

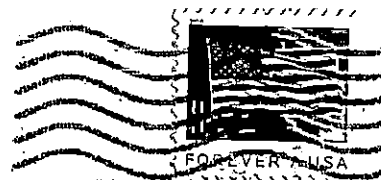
