

Dear Ms. Kitchings:

I previously served opposing counsel with a copy of the Record on Appeal in this matter. Unfortunately, I subsequently discovered that the unbound copy I had sent opposing counsel was the copy I had sent to the printer to have page numbers added to and the ROA printed. I thought they had put the numbers on the copy I sent them and it frankly just did not occur to me that they might not have numbered that volume. I was advised of this problem by opposing counsel's administrative assistant. It was originally my intent to just email them a copy with the proper numbers. Then I discovered that the Record on Appeal was going to have to be completely redone anyway because there had been a significant printing error. The outside printer I use had placed the new numbers for the Record on Appeal right at the end of the original numbers. There was no separation between the old numbers and the ROA numbers at all. In light of this printing error, I am asking that I be given five (5) additional days to finish up my Final Brief of Appellant and have it served and filed. I actually hope to be able to get the ROA and the Final Briefs finished and delivered tomorrow, but do not want to cut it so close that I might have to request more time. For now, I remain,

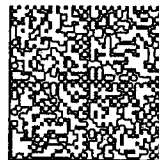
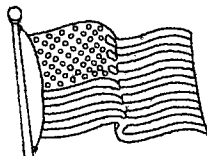
