Dear Ms. Kitchings,

I am writing to respond to a copy of a letter from you to SCDC General Counsel, Christopher D. Florian, and dated Feb. 19, 2013, requesting of him to provide the court with documentation showing that I had received the Educational Credits for the time period of July 24, 1995 to April 11, 1996, whereby counsel contends that I have been given that credit, and that the matter is now therefore "Moot." I am compelled to Respond because the matter is not moot, I have only received 30 Days off my sentence, but I am owed 9 Months More.

I was not given "Educational Credits," but I was instead given "Earned Work Credits," which is what I am suppose to get under SCDC Policy OP-21.07, Sect.(2.2) which I have raised the entire time of this matter. I wrote SCDC Headquarters requesting a Copy of the New Sentence Calculation that was done on August 28, 2012, because I wanted to see how they only gave me 30 Days, I am therefore attaching a Copy for this Court so that the Court can see the Response, I received the response on Jan. 22, 2013, this matter is not Moot, I should already be Maxed-Out or home on Supervised Furlough, I am not, and will not sue the SCDC, I just want my time and this matter is Ended.
