NOTICE OF APPEAL

I, Alice H. Anderson, this 5th day of February 2020, am appealing Judge Diane S. Goodstein's Order granting Defendants' Motion Summary Judgment in the Court of Common Pleas for the Ninth Judicial Circuit Case No.: 2018-CP-10-02963 for Alice H. Anderson (Plaintiff) vs. Robert Michael Drose and Drose Law Firm (Defendants) which was electronically filed on January 08, 2020.

I filed a Chapter 13 bankruptcy with Michael Drose of Drose Law Firm in Charleston, SC on May 24, 2013. I missed one payment during my settlement agreement with Caliber so I informed Attorney Drose and he and his staff then began requesting numerous documents be sent to

him which I did; he told me to stop paying the Bankruptcy trustee and that he would let me know if he heard anything from Caliber which he never did, but he and his staff continued to request documentation from me as if he was working on this foreclosure with Caliber. Michael told me months later that he never entered to appear at the foreclosure hearing in Orangeburg, SC and stated he thought I decided to let the property go because it needed repairs. I told him I never told him I would let the property go. I did not understand why he waited so late to tell me this information and I asked did I need to appear and he said no.

Peter Dimery who was working at Drose Law firm requested Lender's Placed Insurance documentation 2-3 days prior to the foreclosure in Orangeburg, SC to send to Caliber, but nobody at Drose Law Firm ever told me they were not working on this foreclosure.

Attorney William Ney submitted an Affidavit stating that Attorney Drose led me on as if he was working on this foreclosure, but he really was not working on it.

I am asking the Court of Appeals to review this case and overturn Judge Goodstein's Order because Attorney Drose and his staff neglected to provide an ethical duty of care to represent me as his client and he should have just told me the honest truth. *Vinson v. Hartley*, 324 S.C. 389, 399, 477 S.E.2d 715, 720 (Ct.App.1996). I asked Attorney Drose to call Caliber to help me, but he refused to and stated he apologizes if he dropped the ball.

I appreciate you taking the time to acknowledge my appeal.

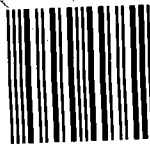

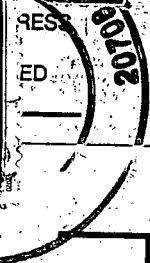
