MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF
OF APPELLANT AND DESIGNATION OF MATTER

Counsel for Darryl Eugene Coleman respectfully requests a **fourth and final thirty (30) day extension, until March 4, 2020**, in which to file the Initial Brief of Appellant and Designation of Matter in the above-referenced case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed with the Court today. The Court has granted counsel three previous extensions.
2. Counsel for Darryl Eugene Coleman respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the petition for rehearing in the case of Brandon Heath Clark v. The State of South Carolina with this Court on December 27, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Sandy Lee Locklear v. The State of South Carolina with the Supreme Court on December 23, 2019. Counsel filed the Anders brief of appellant and designation of matter in the case of The State of South Carolina v. Tristian Cummings with this Court on December 20, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jerry Dean Heard v. The State of South Carolina with the Supreme Court on December 4, 2019. Counsel filed the Anders brief of appellant and designation of matter in the case of The State of South Carolina v. Keshawn Melvin Rice with this Court on December 4, 2019.


4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload

will hopefully become more manageable in the near future, and less extensions will need to be requested.


5. Counsel for the Attorney General's office consents to this request shown by signature below.




