Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Seandrea Johnson v. The State with the Supreme Court on December 23, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jeffrey Brown v. The State with the Supreme Court on December 20, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Phillip Lowery with the Court of Appeals on December 16, 2019. Counsel had an oral argument in the case of The State v. Samuel Alexander before the Supreme Court on December 11, 2019.

3. As indicated by her consent below, counsel for the state does not oppose this request.




