ORDER GRANTING THE PLAINTIFF'S MOTION TO COMPEL ATTENDANCE AT THE MEDIATION

This matter comes before the Court by way of the above-referenced Plaintiffs' Motion to Compel the counsel for Covil Corporation ("Covil"), the Receiver for Covil and the representatives of Covil's insurers to attend mediation in Charleston on March 4-6. The Plaintiff's Motion is hereby GRANTED.

Counsel for the Receiver, Mark H. Wall, and the Receiver for Covil, Peter D. Protopapas, as well as representatives from the following insurance carriers are required to attend the mediation in person: Zurich American Insurance Company; Sentry Casualty Company; U.S. Fidelity and Guaranty Company; TIG Insurance Company, as successor in interest to Fairmont Specialty Insurance Company f/k/a Ranger Insurance Company; Hartford Accident and Indemnity Company; and First State Insurance Company. Each carrier's representative is required to attend mediation with full settlement authority as defined by the South Carolina Supreme Court and the South Carolina Alternative Dispute Resolution Rules.
