MOTION FOR EXTENSION OF TIME TO FILE APPELLANT'S INITIAL BRIEF

1. Counsel for Appellant recently advised the Court that the Transcripts in this matter were ordered and received prior to the filing of this appeal; however, Counsel's office inadvertently failed to properly calendar relevant deadlines for perfecting the appeal based on having previously ordered and received the transcripts. 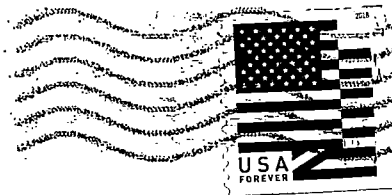
