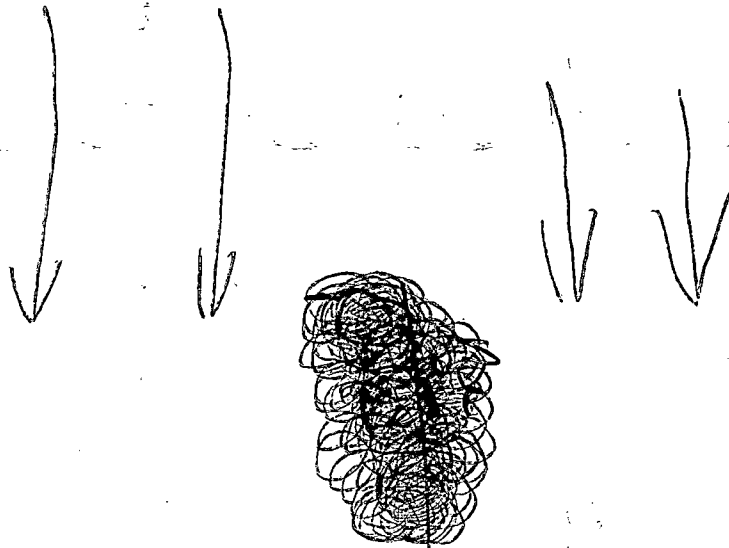

Mess up God cleans up

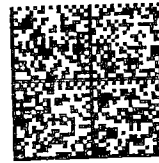
